This session will educate the audience on the statutory and case law relevant to determining the duty to defend and indemnify when the client/insured cannot satisfy the SIR/deductible, and will provide strategies in navigating the common issues.

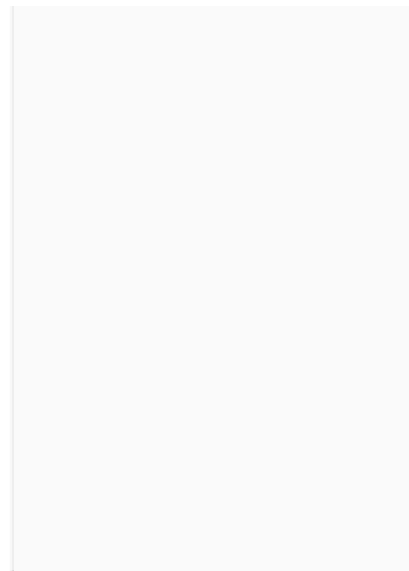
